Officers of the Central Government holding analogous post on regular service in the parent cadre or department.

NOTE : Armed Forces Personnel held substantive rank of **L/NK or Sepoy** in Indian Army or equivalent substantive rank in Indian Air Force/Indian Navy can also apply.

(b) Technician 'B' :

Officers of the Central Government :-

- (i) holding analogous post on regular service in the parent cadre or department; or
- (ii) with eight years of regular service in the post in Level-2 of the pay matrix.

(c) Technician 'C' :

Officers of the Central Government :-

- (i) holding analogous post on regular service in the parent cadre or department; or
- (ii) with six years of regular service in the post in Level-4 of the pay matrix.

(d) Technician 'D' :

Officers of the Central Government :-

- (i) holding analogous post on regular service in the parent cadre or department; or
- (ii) with six years of regular service in the post in Level-5 of the pay matrix.

- (III) Having two years experience in the relevant discipline/field/trade as mentioned above.
- (IV) Having working knowledge of computer.

Note-1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.

Note-2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

Note-3: The maximum age limit for appointment on deputation shall be not exceeding 56 years as on the closing date of the receipt of the application.

For Ex-Serviceman: Deputation/Re-employment

The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation term upto the date on which they are due for release from the Armed Forces; thereafter, they may be continued on re-employment.

3. How to Apply and other Instructions :-

- Desirous eligible candidates are required to apply **ONLINE** by logging on to the website **ntro.gov.in** and applications submitted through any other mode will **NOT** be accepted.

- (iii). This recruitment notice will be uploaded in the above-mentioned website.
